## Resolution adopted by the General Assembly on 17 December 2015

[on the report of the Third Committee (A/70/489/Add.1)]

### 70/144. International Covenants on Human Rights

*The General Assembly,*

*Recalling* its resolution 68/155 of 18 December 2013,

*Welcoming* the forthcoming fiftieth anniversary of the adoption of the International Covenant on Civil and Political Rights<sup>1</sup> and the International Covenant on Economic, Social and Cultural Rights,<sup>1</sup>

1. *Welcomes* the annual reports of the Human Rights Committee submitted to the General Assembly at its sixty-ninth<sup>2</sup> and seventieth<sup>3</sup> sessions;

2. *Also welcomes* the reports of the Committee on Economic, Social and Cultural Rights on its fiftieth and fifty-first sessions<sup>4</sup> and on its fifty-second and fifty-third sessions;<sup>5</sup>

3. *Decides* to devote one plenary meeting of the General Assembly, within existing resources, at its seventy-first session, to the commemoration of the fiftieth anniversary of the adoption of the International Covenant on Civil and Political Rights<sup>1</sup> and the International Covenant on Economic, Social and Cultural Rights,<sup>1</sup> and requests the President of the General Assembly to conduct consultations with Member States in order to determine the modalities for that meeting;

4. *Invites* the Chairs of the two Committees, within existing resources, to address and engage in an interactive dialogue with the General Assembly at its seventy-first and seventy-second sessions under the item entitled “Promotion and protection of human rights”;
